- 1. For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/Fund Transfer to the credit of account number 4663500200004101, Karnataka Bank Ltd, Mandya Branch, IFSC code KARB0000466 or by DD/pay order favouring "Karnataka Bank Ltd., A/c-Mr.Jagadish", payable at Mandya.
- 2. After Online Registration, the intending bidder should submit the duly filled in bid form (format available in the above website: <a href="https://www.auctionbazaar.com">https://www.auctionbazaar.com</a>) along with DD/ quoting the UTR number or NEFT /RTGS remittance towards EMD in a sealed cover as "Tender for property purchase pertaining to A/c -Mr.Jagadish" & duly mentioning the amount offered for purchase shall be submitted to The Authorised Officer, Karnataka Bank Ltd,Mandya Branch on or before 4PM on 26.04.2024.
