- 1) For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve price by way of RTGS/NEFT/fund transfer to the credit of account number **0163500200004101**, Karnataka Bank Ltd, **Adi Udupi Branch**, IFSC code **KARB0000016**. EMD of unsuccessful bidders will be returned.**
- 2) After Online Registration, the intending bidder should submit the duly filled in bid form (format available in the above website) quoting the UTR number of NEFT/RTGS remittance towards EMD in a sealed cover as subscribing "TENDER FOR PURCHASE OF PROPERTY A/c - M/s.
