- 1. For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/Fund Transfer to the credit of account number 4113500200004101, Karnataka Bank Ltd, Koratagere Branch, IFSC Code KARB0000411 or by DD/pay order favouring "Karnataka Bank Ltd., A/c- Mohan K N", payable at Koratagere.
- 2.
