- 1. For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/Fund Transfer to the credit of account number 3043500200004101, Karnataka Bank Ltd, Hassan Main Branch, IFSC code KARB0000304 or by DD/pay order favouring "Karnataka Bank Ltd., A/c-Mr. Chandrashekar", payable at Hassan.
- 2.
