TERMS AND CONDITIONS OF SALE

- 1) For participating in E-auction, intending bidders have to deposit a refundable Earnest Money Deposit (EMD) of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/Fund Transfer to the credit of account number - **9683500200004101, Karnataka Bank Ltd, Bengaluru - H.M.T Layout Branch, IFSC Code - KARB0000968** or by DD/pay order favouring **"Karnataka Bank Ltd., A/c - Mr. Manjunath N and M/s M.N Construction "**, payable at Bengaluru.
- 2) After Online Registration, the intending bidder should submit the duly filled in bid form (format available in the above website <https://www.auctionbazaar.com/>) along with DD/quoting the UTR number or NEFT RTGS remittance towards EMD in a sealed cover as **"Tender/Bid for property purchase pertaining to A/c - Mr. Manjunath N and M/s M.N Construction"** and duly mentioning the amount offered for purchase shall be submitted to the Authorised Officer, Karnataka Bank Ltd., Asset Recovery Management Branch, 1st Floor, FKCCI Building, Kempegowda Road, Bengaluru-560009 **on or before 4.00 P.M on 28.05.2024. - 4) The bid will be open to them and an opportunity will be given to enhance the bid amount in the multiples of **Rs.10,000/-**. Interse bidding among the qualified bidders shall start from the highest bid quoted by the qualified bidders.
