1. For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/Fund Transfer to the credit of account number 6223500200004101, Karnataka Bank Ltd, Mysuru Sankranthi Circle Branch, IFSC Code KARB0000622 or by DD/pay order favouring "Karnataka Bank Ltd., A/c- M/s. Vaishnavi Industries", payable at Mysuru.

- 2. After Online Registration, the intending bidder should submit the duly filled in bid form (format available in the above website: https://www.auctionbazaar.com) along with DD/ quoting the UTR number or NEFT /RTGS remittance towards EMD in a sealed cover as "Tender for property purchase pertaining to A/c -M/s. Vaishnavi Industries" & duly mentioning the amount offered for purchase shall be submitted to The Authorised Officer, Karnataka Bank Ltd, Mysuru-Sankranthi Circle Branch, on or before 27.05.2024 at 4:00 P.M. - 4. The bid will be open to them and an opportunity will be given to enhance the bid amount in the multiples of Rs.1,00,000/- for item No.(2) & Rs.50,000/- each for item No.(1),(3)&(4).
