- 1. For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/Fund Transfer to the credit of account number 4093500200004101, Karnataka Bank Ltd, Kodlipet Branch, IFSC code KARB0000409 or by DD/pay order favouring "Karnataka Bank Ltd., A/c- Mrs. Shubha and others ", payable at Kodlipet Branch.
- 2.
