1. For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/ Fund Transfer to the account number 7803500200004101, Karnataka Bank Ltd, Thanjavur Branch, IFSC Code KARB0000780 or by DD/pay order favouring "Karnataka Bank Ltd., A/c – Mrs.Dhanalakshmi.S", payable at Thanjavur.



2. After Online Registration, the intending bidder should submit the duly filled in **bid form (format available in the above website <https://www.auctionbazaar.com>)** along with DD or quoting the UTR number of NEFT/RTGS remittance towards EMD in a sealed cover as “Tender for purchase of property pertaining to A/c Mrs. Dhanalakshmi.S” duly mentioning the amount offered for purchase shall be submitted to The Authorised Officer, Karnataka Bank Ltd, Asset Recovery Management Branch, No.324, Ground Floor, Thambu Chetty Street, Chennai – 600001 before 4.00 PM on 28.05.2024.
