- For participating in E-auction, intending bidders have to deposit a refundable Earnest Money Deposit (EMD) of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/Fund Transfer to the credit of account number – 9633500200004101, Karnataka Bank Ltd, Bengaluru – Electronic City Phase I Branch, IFSC Code - KARB0000963 or by DD/pay order favouring "Karnataka Bank Ltd., A/c – M/s Star Dress Mart", payable at Bengaluru.
