

- 1) For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/ Fund Transfer to the account number 7613500200004101, Karnataka Bank Ltd, Tiruchirapalli Branch, IFSC Code KARB0000761 or by DD/pay order favouring "Karnataka Bank Ltd., A/c – Mr.S.R.Parani", payable at Tiruchirapalli.

- 3) In case the bidder is a company, a copy of the resolution passed by the Board of Directors authorising the actual bidder to participate in the auction on behalf of the company should be submitted.
- 4) The bid will be open to them and an opportunity will be given to enhance the bid amount in the multiples of **Rs.20,000.00**. Interse bidding among the qualified bidders shall start from the highest bid quoted by the qualified bidders.
