#### TERMS AND CONDITIONS OF SALE:

1. For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/ Fund Transfer to the account number 1523500200004101, Karnataka Bank Ltd, Chennai-Porur Branch IFSC Code KARB0000152 or by DD/pay order favouring "Karnataka Bank Ltd., A/c - Mrs.Basavaraju Sathyapriya", payable at Chennai.
2. 3. In case the bidder is a company, a copy of the resolution passed by the Board of Directors authorising the actual bidder to participate in the auction on behalf of the company should be submitted.
4. The bid will be open to them and an opportunity will be given to enhance the bid amount in the multiples of Rs.10,000.00. Interse bidding among the qualified bidders shall start from the highest bid quoted by the qualified bidders.
