



**TERMS AND CONDITIONS OF SALE:**

- 1) For participating in E-auction, intending bidders have to deposit a refundable Earnest Money Deposit (EMD) of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/Fund Transfer to the credit of account number - 1043500200004101, Karnataka Bank Ltd, Bengaluru - Basaveshwarnagar Branch, IFSC Code - KARB0000104 or by DD/pay order favouring "Karnataka Bank Ltd., A/c - M/s Bunt Solar India Pvt. 


