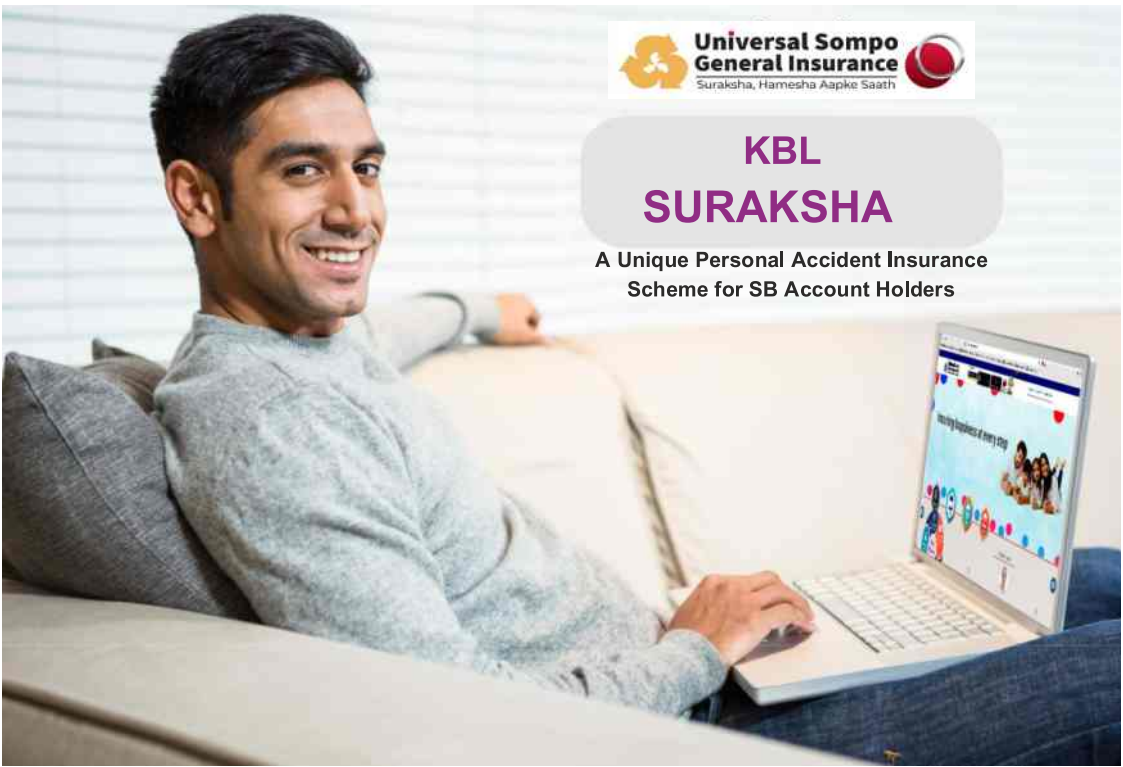

SALIENT FEATURES

- **Eligibility** : SB Account Holders of Karnataka Bank
- **Entry Age** : 18-80 Years
- **Term** : 1 Year* and renewable every year thereafter [Auto Debit facility available for Renewal]
- **Premium** : Same Premium for All Age Groups

TERMS AND CONDITIONS

- Coverage : Accidental Death + 1 Child Education of Rs.15,000/- (Age of Child: 3 -25 years).
- Eligibility : SB Account Holders of Karnataka Bank.
- Entry Age : 18 to 80 years.
- The maximum renewal age will be up to life long, subject to payment of renewal premium on before the expiry of the master policy.
- An account holder can enroll during the tenure of the master policy by paying full annual premium plus applicable service tax .
- One Policy per individual is allowed.
- Annual premium is subject to changes at the time of renewal.
- The Renewal of Master Policy will be done as per policy period

Mandatory Documents

- Claim Intimation (within 90 days of the event)
- Duly filled Original Claim Form
- Duly filled Bank Mandate Form
- FIR – Attested or Original
- Postmortem Report – Attested
- Death Certificate – Attested Copy
- Inquest/Coroner's Report – Attested
- KYC documents of Nominee
- Any other documents requested by the claim settling Authority
